



Disclaimer, Waiver and Release of Liability

This Agreement is made by and between the undersigned LAB PARTICIPANT and The Steadman Philippon Research Institute (SPRI). This Agreement will remain on file at the Steadman Philippon Research Institute and is in effect for the duration of one (1) year from the date signed below.

LAB PARTICIPANT agrees at his or her discretion to wear appropriate attire and personal protective equipment at all times in the Steadman Philippon Research Institute Surgical Skills Lab. This includes, but is not limited to, scrubs and/or gown, gloves, closed-toe shoes, shoe covers, and eye protection.

LAB PARTICIPANT represents that he or she fully understands Universal Precautions as defined by the Occupational Safety and Health Administration (OSHA) laws and regulations and agrees to follow the Universal Precautions and any other Lab and Safety precautions. Hazardous material and sharps shall be disposed of properly.

SPRI's tissue supplier has certified that all tissue specimens provided by the SPRI to LAB PARTICIPANT have been screened and serologically tested for human immunodeficiency virus (HIV) types 1 and 2, hepatitis B surface antigen (HbsAg), HBV, and hepatitis C virus (anti-HCV). No other diseases have been tested unless otherwise requested in writing by LAB PARTICIPANT at least *28 days* prior to the lab.

SPRI will not release tissue that has been tested serologically and confirmed as positive reactive. All other tissue may be released at the sole discretion of SPRI.

LAB PARTICIPANT is fully aware that handling of human tissue is a hazardous activity.

LAB PARTICIPANT agrees to release and hold harmless SPRI, its owners, officers, directors, employees, agents, contractors and affiliates from any and all liability loss, claim, damage or injury that might arise or result from, or relate to, now and in the future, LAB PARTICIPANT'S contact with tissue specimens while using the SPRI Surgical Skills Lab.

LAB PARTICIPANT agrees to comply with all state and federal laws and regulations regarding the handling of human tissue and anatomical specimens, including but not limited to, OSHA laws and regulations.

LAB PARTICIPANT understands that it is the policy of SPRI to treat donated human anatomical specimens with the utmost respect and gratitude at all times, and LAB PARTICIPANT pledges to comply with this policy.

LAB PARTICIPANT understands that the unauthorized use of photographic, video and other electronic recording equipment in lab events supported by SPRI in rooms containing human tissue is expressly prohibited.

LAB PARTICIPANT has read this Agreement and understands its content. This Agreement with SPRI is being signed of LAB PARTICIPANT'S own free will. This Agreement is governed by the laws of the State of Colorado.
